

COLLECTIVE BARGAINING AGREEMENT: BRICKMAKING AND CLAY PRODUCTS MANUFACTURING INDUSTRY: EFFECTIVE 28th of JULY, 2023

This Collective Bargaining Agreement, made and entered in accordance with the Labour Act (Chapter 28:01) as amended from time to time between the Brickmaking and Clay Products Employers Association (hereinafter referred to as "the employers") of the one part, and the Brickmaking and Clay Products Workers Union (hereinafter referred to as "the employees") of the other part, being parties to the National Employment Council for the Brickmaking and Clay Products Industry to lay down minimum conditions of service for the Brickmaking and Clay Products Manufacturing industry of Zimbabwe.

Duration of fixed term contracts

A contract of fixed term duration shall be deemed to a be a contract without limit of time upon the expiration of a continuous period of four (4) years for skilled workers, five (5) years for semi-skilled workers and five (5) years for workers in Grade A and B, provided that these employees are not employed as seasonal or casual employees, and are on fixed term contracts renewed from time to time without any break during industry shutdown. The provisions of this agreement shall not apply in retrospect. Continuous service shall be as stated in section 35(1) of Statutory Instrument 151 of 2020.
